Pursuant to § 2 clause 10-11 of the rules and regulations (hereinafter: the „Rules”) of the Ed Sheeran’s concert held at the National Stadium in Warsaw (hereinafter: the „Event”), organized by FKP Scorpio Poland Spółka z ograniczoną odpowiedzialnością, ul. Koszykowa 61, 00-667 Warsaw, entered into the register of entrepreneurs by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under the NCR number: 0000788489, with the share capital of: 200.000,00 zlotys, tax identification number (NIP): 7010929037, statistical number (REGON): 383531203 (hereinafter: the „Organiser”), I hereby:

1. represent that the Minor will stay at the Event under my custody or respective supervision and on my own exclusive responsibility.

(it refers to the Minors at the age of 5 to 16)

2. give my consent to the participation of the Minor in the Event and represent that the Minor will stay at the Event on my own responsibility.

(it refers to the Minors at the age of 16 to 18)

Concurrently, I represent that:

- 1) I am aware of the contents of the Rules and that I fully accept these provisions;
- 2) acting as a statutory agent of the Minor I hereby give my consent to granting by the Minor all consents and permissions required according to the Rules, and - to the extent to which the Minor is not fully capable of granting valid and effective consents and permissions - I hereby grant such consents and permissions in his/her name and on his/her behalf;
- 3) I give my consent to the Organiser to process my personal data specified in the Statement, for the purpose of documentation of my representations and consents given above in connection with the Minor’s participation in the Event;
- 4) I am aware of the information clause on the second page of the herein Statement.

Koszykowa 61, 00-667 Warsaw, entered into the register of entrepreneurs by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under the NCR number: 0000788489, with the share capital of: 200.000,00 zlotys, tax identification number (NIP): 7010929037, statistical number (REGON): 383531203 is a controller of personal data specified in the Statement (hereinafter: the "**Controller**").

Personal data is processed based on your consent, for the purpose of documentation of your representations and consents given in the Statement in connection with the Minor's participation in the Event. Personal data is processed until the moment of withdrawing the consent or until the lapse of a 3 (three) months period commencing as of the end of the Event, whichever happens earlier.

Personal data is also processed for the purposes arising from legitimate interests pursued by the Controller, such as making claims – in order to carry out all pre-trial, trial and enforcement activities, aiming at satisfying the Controller's claims or at the Controller's defence. Personal data is processed until the lapse of limitation period for the claims.

The Controller may disclose the personal data to the service providers, who are entrusted with data processing, including the entities providing accounting services, legal services or IT services. Personal data may also be disclosed to the entities affiliated with the Controller or to the entities authorised based on legal provisions in force.

The Controller informs, that you have the right to

- 1) access your personal data, obtain a copy of your personal data, rectify your personal data, erase or restrict its processing, as well as the right to transmit the data;
- 2) withdraw the consent to data processing at any time; the withdrawal of consent shall not affect the lawfulness of processing the personal data based on consent before its withdrawal;
- 3) object at any time, for reasons related with your particular situation, against processing of your personal data for the purposes arising from legitimate interests pursued by the Controller;
- 4) file a complaint concerning the personal data protection with a supervisory authority, i.e. with the President of the Personal Data Protection Office.

Giving personal data and consents specified in the Statement is voluntary yet indispensable for Minor's participation in the Event.
